since the International Security Assistance Force (ISAF) arrived in Afghanistan carrying out three specific slogans, [Missions] (1) Suppressing International Terrorism. (2) Eradication of narcotics. (3) Establishing good governance, but unfortunately failed to implement these three important commitments, not only these three commitments fulfilled, but along with their arrival new unrest broke out in Afghanistan. Such as increasing in cultivation, production, processing and use of narcotics, increasing in terrorist groups, insecurity, corruption, lawlessness, violation of human rights and so on. eventually the irresponsible withdrawal of international forces from Afghanistan has left many miserable mysteries to the people of Afghanistan, it means that not only the missions have fulfilled, but created more problems for Afghans. As a result, Afghans have become distrustful of the international community, especially NATO. This is not just a matter of political circles; it has worried every single Afghan. in the meanwhile, On the 24, Feb 2020 General Hamdullah Nazek gathered like-minded and number of Intellectuals and shared the mentioned Concerns with them, after a serious Investigation and studies it was found, that the risk is very serious that every Afghan male and female, civilian and the military rural and urban, literate and illiterate. Representatives of political parties, generals of security agencies, judges, district governors, prosecutors, journalists, women's rights activists, civil society activists, cultural figures, religious scholars, tribal elders, trade unions and representatives of all walks of life joined the movement. They agreed that the rule was wider than before and it was called the National Integration Movement of Afghanistan. He later joined a charity called NIMA and a law firm. Since then, we have been collecting the signatures of civilians who want to raise their voices against NATO and its allies through the National Integration Movement of Afghanistan, which is in the form of a petition. The security was being asked from the International Court of Justice under the name of National Integration Movement, The National Integration Movement of Afghanistan was formed of 41 members called the High Council over time number of the high Council escalated to 233 members, a Leadership Council that consists of 31 Members, and Trustees which consists of 11 members. It should be noted that the organization was not political at all But it was created to advance a legal lawsuit.

every decision is being made under their supervision. The Leadership Council decided to form an Administrative Committee. [Trustees] Formed through elections, the leadership council has the authority to oversee the movement's activities, but the number of members could change.

NIMA, an independent charitable foundation, has a license from the Ministry of Justice of the Islamic Republic of Afghanistan and provides financial support to the National Integration Movement of Afghanistan, as well as Nima Hemat Legal Consulting Company of Afghanistan.

Over the past year, numerous institutions and grassroots movements, as well as political and popular figures across Afghanistan, have supported and advocated for the Afghan National Integration Movement.

Until July 21/202143,000 petition forms for security and immunity by the people of Afghanistan have been submitted to the Nima Office, of which 25,000 have been reviewed and approved, 10,000 are being reviewed, and another 8,000 compared to Incompleteness of the conditions of the lawsuit has been annulled. Litigation forms, along with the petition and the National Integration Movement of Afghanistan, will be sent to the United Nations, the Supreme Court and other relevant international organizations for follow-up.

The National Integration Movement of Afghanistan has five committees: 1- Military Immunity Committee, 2: Social Immunity Committee, 3: Economic Immunity Committee, 4: Legal Immunity Committee, 5: Environmental Immunity Committee.

10 preliminary articles of the declaration (Plan) of National Integration Movement of Afghanistan. The date of circulation : Tuesday 09 Thawar, 1399 (28th.April, 2020)

The people of Afghanistan are the victims of international terrorism and make personal and financial sacrifices every day. Afghanistan is a strategic partner of the international community in the ongoing war against international terrorism, and currently it has military and civilian presence in Afghanistan but the ongoing war in Afghanistan, political crisis, corruption, lawlessness, peace covert and overt efforts, vague attempts for the release of prisoners, drugs, threats to Islamic, civil and human rights are those things that not only causes concerns to every Afghan but affect the lives of all Afghans every day. In practice, problems are added by each passing day.

Over the past nineteen years all sections of Afghanistan have sacrificed their lives in the war against international terrorism and for the protection of democracy, national interests and human rights in Afghanistan. Religious scholars and clergies have raised their voices, senior security officials and soldiers have fought in frontlines and local people have revolted in villages. Judges, prosecutors and lawyers have served the justice, Afghan investors have invested in the economy, and the public have again and again supported the government, national political movements, civil society, intellectuals, and influential figures have always stood behind the government. But today when Afghanistan's national interests are ignored and threatened, their concerns are well-founded.

Over the past nineteen years, new political movements, civil and social movements and ideas have born in the country. Currently, there is no region and group of Afghanistan that is not financially and intellectually aligned with these new ideas and values. But now without consulting with the important layers of society in the peace process of Afghanistan such as; political parties, civil movements, women's rights groups, religious and spiritual figures and prominent figures in the community, ignoring Islamic values and the national interests of Afghans peace with the Taliban will not bring the desired outcome for both us and the international community. The peace agreement with the Taliban without strong international guarantees and not disrupting the financial resources of international terrorists has concerned the Afghans. Page 7 of 68

The problem is that no one feels safe in Afghanistan anymore and Afghans have no political, military, economic, social, environmental protection. Our basic demand is that we want peace for all Afghans and this notion has forced the nation to form "The National Integration Movement of Afghanistan (NIMA)" to express their concerns through this address.

The movement brings together hundreds of current and retired generals from National Security Departments of Afghanistan, members from civil society, trade unions, judges, prosecutors, lawyers, community leaders, politicians and many others from different parts of the Afghan community. The National Integration Movement of Afghanistan (NIMA) had planned to hold a large gathering to protest its concerns in the ongoing peace process but due to the COVID19 PANDEMIC instructions from the Ministry of Public Health we have postponed the large gathering for right now and we will be gratified with a notice and this declaration. Not only we have objections to the Afghan government and the international community on the ongoing peace process but at the same time on behalf of different segments of the nation we have drafted a comprehensive political plan that can help both the Afghan government and the International Community. The plan is presented as follows:

1. We support inter-Afghan negotiations, but the national interest of Afghans must be preserved in the negotiations.

2. A permanent ceasefire between the government and the Taliban is needed to increase trust between the two sides of the conflict and pave the way for lasting peace.

3. Drugs in Afghanistan are a global phenomenon and a major financial source of international terrorism but local Afghans are its victims. We want this issue to be included in the inter-Afghan talks with the Taliban.

4. We want peace in Afghanistan but a peace that protects both the national interests of Afghans and eliminate the elements of terrorism that allows other terrorist groups to thrive.

5. The Taliban assured the Americans in the "Qatar Peace Agreement with Taliban" that Afghanistan's soil will not be used against the Americans, but we want assurances from the international community, especially from the United States and Britain that the soil of neighboring countries should not to be used against Afghanistan.

6. The people of Afghanistan especially the military, the judiciary, civil servants and academics who have fought against terrorism in Afghanistan for nineteen years, as a vital part of the Afghan society they should be included in after peace government and Afghan community need to benefit from their expertise about peace and governance.

7. We believe that Afghanistan's national interests can only be safeguarded (in a democratic system). We opposed any compromises on (democratic system) in peace negotiations.

8. We support the exchange of prisoners between the Taliban and the government but if the Taliban prisoners who are convicted of drug trafficking and terrorism are supposed to be released, then those prisoners who are convicted only for drug offenses should also be released.

9. Afghan military officers, prosecutors, judges, lawyers and civil servants have been involved in arresting and prosecuting of the Taliban prisoners who are supposed to be released in the peace agreement, the security of those military and civil servants of the government must be guaranteed.

10. Weapons are a major factor in war. Anyone who makes peace with the Afghan government should raise the issue of weapons collection. If left unchecked, there are fears that the weapons could fall into the hands of another militant group and the war could continue.


Note:

Five immunities and 14 articles of the Second Declaration of the National Integration Movement of Afghanistan. The date of circulation : Wednesday 5 Sonbole, 1399 (26th. Aguste, 2020)

NIMA is a National Integration Movement which has been constituted through Political, Religious scholars, Tribal Elders, renowned personalities and Social activist, to protect the entire Nation. NIMA is not a Social Association, and not a political Organization till now, indeed it is a National Movement, the main goal is to provide protection to every single person in Community, our Movement is not an opposition Organization and not a part of the government, if anyone such as Government, political parties, Social Activist, and the renowned personalities support us, they are most welcomed, we are not blaming each other inside Afghanistan, we understand whatever misery is happening in Afghanistan come from across the border, since our issue is on International level, so it must be referred to the International Community and court of justice, the proposal has been legally prepared and has been submitted to the International judicial and human rights organizations, in addition it has been submitted to several foreign embassies as well, we have been contacted by some foreign officials that they have already received the case, and they confirmed it, it is under their consideration, but some of them haven't contacted yet, because of COVID19 restrictions, majority of them are closed, or they might be still following world health organization precautionary measures, as soon as quarantine, or the COVID19 restriction is over we will hire the lawyers and take the case to the international level, the government is also a part of the Nation, if we are supported by the Unite Nation and declared the winner, it is going to interest the Government as well. as we asked for help from the government to take our case to the International Community, and also shared it with the Afghan Parliament, National Security, foreign Ministry, and presidential head Office, unfortunately we haven't received any response back yet, the National Integration Movement is focusing on two main objects, 1- to take our case to the judicial and civil rights organization, and parliaments, in the meantime to have dialogs with political parties to discuss and convince their government authorities, further than to convince the United Nation through 1386 Bonn resolution, that the entire nation is being faced with destruction, we are also a part of the existing world, we have the right to rise our voice and the united Nation has to support us through Human rights value, 2nd – on the other hand we call for unity and integration, we had meetings and dialogs with deferent people of the community, so nobody feel safe, the name of our case is (National Protection) which we have divided into five primary Categories. #### 1 - Political protection

1: The Special representative of the united states and president of Donald Trump, Mr. Zalmai Khalilzad hasn't clearly shared bilateral peace agreement details with the Afghan Nation yet, as Afghans are the bilateral partner of the peace negotiation, they should not be deprived, so the meaningful and comprehensive details of the agreement must be shared with Afghan Local National, we should be informed for further progress of peace negotiation, otherwise we will have a very deep concern.

2: whenever the government of Taliban was collapsed by the US and its Allies their main target was to eradicate Taliban regime, eliminate the terrorism, and to build a democratic system institution, Taliban was blamed and called them guilty, because of having closed relationship with Al-Qaida's leader Osama Bin Ladin and his supporters who were in Taliban's protection, actually United States didn't make peace agreement with remaining International terroristic groups, such as Al- Qaida and etc, who still exist, it was just a bilateral peace agreement between Taliban and United States, who will take the responsibility that there will be no war after peace agreement with Taliban? Because Taliban were not the main perpetrators of the war and they are not as well, but the main cause of the war is International Terrorism and International Narcotic Drugs Mafias, we are having a deep concern that the main cause of the war has been left behind unattended, US has never assured and provided such as sufficient enough information yet, since there was only Al-Qaida existence before, but currently we have the presence of several deferent terroristic Organizations in Afghanistan, we understand the current war is more intense and complicated compared to the past, as we supported peace negotiation and still support it as well, but the main concern is bilateral peace agreement that more likely will lead another domestic conflict in Afghanistan, so it is important to look for the main cause of the problem, and the financial source of their income, it has to be mentioned the international drug traffickers are the main source of their income, which is across the border outside Afghanistan. 3: United States and its allies assured the Afghans to eradicate the terrorism, eliminate the drug cultivation, and to build a democratic system institution, unfortunately none of the above three commitments or circumstances have accomplished yet, the people have suffered a lot, explanation is needed to be provided to the Afghan Nation, that who is responsible and what will be its consequences.

4: After the ceasefire and peace agreement between US and Taliban, that not only decreased the fight, but Taliban involved increasingly in more intensive combat and domestic violence, the local national and public interests plus facilities have been suffered throughout fighting. As we mentioned in our first declaration, the 2nd declaration is the same as well, that long lasting peace and ceasefire are extremely needed, so we ask from the International Community particularly from the US and Taliban that before bilateral peace negotiation between Afghan Government and Taliban long lasting ceasefire is needed.

5: As Taliban assured the US that they will eliminate the contacts with other terroristic groups, but they didn't assure the US to eliminate contacts with Drug Mafia's groups same as well, so it must be part of upcoming bilateral Peace Negotiation.

6: A large number of Chemical, Narcotic Drugs are being produced in Afghanistan, the chemical which convert it to the real drugs such as Heroin, Cocaine, and etc., comes from the neighboring countries, united nation has to call the neighboring countries to seal their boarders on their faces, indeed they have sufficient enough capability to seal the boarders, somehow they don't, it means their Military agencies are involved with International Mafias.

#### 2: Military Forces Protection

7: Our political stability, national security, and unity including Homeland protection depend on

Security's skills and merits, we are deeply concerning about its protection, we ask from the Government of Afghanistan to rid the security agencies from political, ethnic tendencies

and corruption as well, As the United Nation and the US are obligated to response in details that

What will be the fate of security agencies in the future, because Taliban clearly confessed

In front of the world social Medias in Qatar that the current security agencies will be disbanded,

And we don't want to go through the bitter experience and miseries once again back to 90 nineties.

#### **3: Social Protection**

8: since we already supported releasing agreement of the prisoners to be freed and still support it as Well, but we Claim their lives to be safe and guaranteed, we hope they will return back to

The normal Life, no one will harm and no one will encourage them to join the fighting groups

Once again. We seek the rights of the veterans from the International Community who lost their lives (Martyrs) or members of their families and who lost parts of their bodies (Disabled) in the war against International terrorism.

9: We ask security for the entire Afghans, if there is no such a strong International guarantee

base on Afghan and Taliban peace agreement, more likely it will lead another domestic

conflict in Afghanistan, it is being requested, the US and Britain have to bail them, in case Taliban join the government and likely another terroristic faction would replace, be on their spot, it will be another life threat and a big risk for the public to support Taliban, so we ask their financial, life threat and honor protection as well.

10: Afghanistan has bilateral security agreement with the US, and it has been years that eastern Afghanistan (Kunar) province is under Pakistan rockets attack, it is strongly requested to the US to stop the rockets strike over Afghan territory or to provide us the logical explanation that why there is no respect to the bilateral security agreement at all,

11: Afghans are being suffered in the whole world, their rights are being taken away, recently closed to the Iranian border several Afghans were shot to death, burned alive, sunk in the river, we ask from the Human Rights Organization to protect the rights of every single Afghan,

12: Taliban is one of the armed militant group, whenever the US is making bilateral peace agreement with Taliban, and they are integrating into the Government system, what will be the future destiny of the Military Officers who served for the last 19 years in the Armed forces and fought against International Terrorism, especially retired Judges, Lawyers, government officials, and Advocates whoever struggled for Democracy, Human rights, Islamic merits, and against Narcotic drugs, what will be their fate in future, who will be responsible, that there will be no threat to their life and they will be safe, who can guarantee that the entire Taliban will respect and keep the peace and they will never be divided into several groups, and never return back to war once again, response with specific detail is needed, particularly United States and Britain need to provide us further details. #### 5: Environmental protection

14: Drugs cultivation and production companies in Afghanistan affected surrounding environment, and the profits go direct to the international Mafia's pockets, and our poor people paying high price to import fruits, vegetables and flour from the neighboring Countries, the drug traffickers are encouraging the formers to dig well as much as to find water, the water level is decreasing every day, which is an upcoming risk for us in the future.






National Integration Movement of Afghanistan Trustees Structure







This office has approached the UNAMA Office in Kabul and met Mr. Stephen in Peace Unit on 25 July 2020 virtually and also had meeting with Ms. Juliana, Political Affairs on 5 Jan 2021. We submitted the initial application to Ms. Juliana and also submitted the 7,000 hard copy of the petitions to your esteemed office and the rest of petitions promised to submit to your office as soon as the petitions is collected.

Now, the NIMA office has collected over 30000 hard copy petitions from Afghan public and ready to handover the petitions to your esteemed office.

The chair of NIMA Office also request for either virtual or in person meeting with UNAMA political representative to discuss further raised by Afghan public to be convoyed at Doha peace negotiations table and future groups involved in Afghanistan ongoing peace and conflict issues.

It is noting that almost 500 to 700 individuals visit the NIMA office on daily basis and they are expecting to solve the current violence through a lawful means. Therefore, in order to submit the rest of petitions to your office. Please let me know your most convenience date and time to submit the petitions and meeting either in person or virtually.

Noting to the current security and political situations, the meeting is very crucial at this time. Your time is vital to meet us in this above matters.
